# If Someone Tells You They Have **Experienced Sexual Misconduct**

#### WHAT TO DO

- 1. Tell them you want to offer support, but that you're required by law to report the incident to the Title IX office. If they prefer to talk to someone allowed by law to keep it confidential, hand them the list on the tear-off portion of this card.
- 2. If the person's health or safety is an immediate concern, contact Campus Safety at 413.597.4444 or local emergency services at 911.
- 3. Listen to the person! Ask them if they want help connecting to counseling or Campus Safety. Respect their answers: People who have experienced misconduct may be reluctant or scared and need time to consider their options.
- 4. As required by law, immediately report the incident to the Title IX coordinator at 413.597.3301 or tcc2@williams.edu; or to any of the deputy Title IX coordinators listed on this card. They can also help with questions about what more you can do.

Tear this card at the perforation. Keep this half of the card for your information, and provide the other half to the person who has experienced misconduct.

## If You Have Experienced Sexual Misconduct

### WHAT TO KNOW

- · You set the pace.
- · You have the right to choose to whom you speak, what resources you use and what you say and when.
- · There are many resources at the college and in the community. A list is on the reverse side of this card.
- · It's your choice whether to name the other person(s) involved.
- · Your information will always be kept private, which means it will only be shared with those who need to know: for example, the Title IX coordinator and sometimes Campus Safety.
- · There are specific people you can talk to, called "confidential resources," who are legally allowed to hear your story without reporting it. A list of confidential resources is on the reverse side of this card.
- · We want to take care of you and keep you safe, and we want to make sure that others in the community are safe. Williams College prohibits sexual misconduct.

### WHAT TO DO If you experience sexual misconduct, please

consider the following actions: · Get to a safe place.

- · Contact Campus Safety and Security at 413.597.4444 or emergency services at 911
- · Seek medical attention Williams Health Center: 413.597.2206 Psych Services: 413.597.2353
- · Report the situation to the Title IX coordinator: 413,441,3301
- · Contact a trained, experienced counselor or confidential resources. Both lists are on the reverse side of this card.
- · Contact parents, relatives or close friends for support.

Preserve evidence. If at all possible, do not bathe, change clothing, use the restroom or brush your teeth. If an assault has happened recently (within the last five days), evidence collection is an option. You do not need to report to the police to have evidence collected. Preserving evidence can leave options open for future prosecution. Sexual Assault Survivor Services (SASS), at 413,597,3000, can arrange transport to local hospitals and support throughout the evidence collection process.
